End-User License Agreement for VoiceCharts

- Use the Software and/or Device for any illegal or unauthorized purpose.
- Modify, reverse engineer, decompile, or disassemble the Software or Device.
- Rent, lease, or sublicense the Software or Device.
- Use the Software or Device to transmit any infringing, libelous, or otherwise unlawful or tortious material.
- Use the Software or Device in any manner that could damage, disable, overburden, or impair VoiceCharts' servers or networks.
- Interfere with any other party's use and enjoyment of the Software or Device.
- Use the Software or Device to access or collect any personally identifiable information of any third party without their consent.
